**INFORMATION REGARDING THE PROTECTION OF PERSONAL DATA PURSUANT
TO OF ART. 12 and ss. EU REGULATION 679/2016, OF THE D.LGS. 196/2003 AS
MODIFIED BY D.LGS. 101/2018 AND THE PROVISION OF 8 APRIL 2010, IN THE
MATTER OF VIDEO SURVEILLANCE**



Our The Company has always been very attentive to the aspects of personal data protection and respect for the principles of confidentiality and the dignity of people.

Pursuant to the new EU Regulation 679/2016 and the Provision of 8 April 2010 on video surveillance, in compliance with the principle of accountability, any processing of personal data must be lawful, correct and transparent. These principles imply that the interested party is informed of the existence of the same, of its purposes and of the rights that he can exercise.

In this perspective, the data controller provides the data subject with the information necessary to ensure correct use in further fulfillment of the principle of accountability.

With this in mind, please read the following information.

Jolly Caffè S.p.a., with registered office in via di Vacciano 9, 50012 Bagno a Ripoli (FI), tax code and VAT number 01349450484, in its capacity as Data Controller, in the person of the pro-tempore legal representative, pursuant to and for the purposes of EU Regulation 679/2016, hereby informs the interested party that the personal data acquired concerning him, acquired by the Data Controller or which will be requested later and / or communicated by third parties, are necessary and will be used for the purposes indicated below.



PURPOSE OF THE TREATMENT

Any personal data relating to the interested party collected through the video surveillance system and the use of related devices will be processed in cases where it is essential for the pursued security purposes (protection from theft, robbery, damage, intrusion).



LEGAL BASIS OF THE PROCESSING

Processing is lawful under the following conditions:

- Pursuant to art. 6, paragraph 1, lett. d) EU Regulation 679/2016, the processing is necessary for the protection of the vital interests of the data subject or of another natural person;
- Pursuant to art. 6, paragraph 1, lett. f) EU Regulation 679/2016, the processing is necessary for the pursuit of the legitimate interest of the data controller or third parties, provided that the interests or fundamental rights and freedoms of the data subject that require the protection of personal data do not prevail, in particular if the person concerned is a minor. The legitimate interest of the Data Controller is connected to the safety and protection of company assets.



METHOD OF TREATMENT AND OBLIGATION OF CONFIDENTIALITY

The data processing is performed using IT tools and / or paper supports, by subjects committed to confidentiality, with logic related to the purposes and in any case in such a way as to guarantee the security and confidentiality of the data. The data collected will not be disclosed and disseminated to third parties in accordance with the law.



COMMUNICATION TO THIRD PARTIES

Your personal data may be disclosed to third parties known to us only and exclusively for the aforementioned purposes and, in particular, to the following categories of subjects:

- External companies that perform services on our behalf;
- Bodies and Public Administrations for legal obligations;
- Professionals who can be of support in compliance with the law.

These subjects will process personal data as managers or independent data controllers.



STORAGE TIMES

The personal data of the interested parties will normally be stored according to the legal deadlines, i.e. 24 hours, except for 72 hours during the holiday periods when the offices are closed.

The same terms may be modified to meet the need for security of public order or may be made available to the competent Authorities, exclusively as judicial evidence.



RIGHTS OF THE INTERESTED PARTY

Pursuant to current legislation, the interested party may assert their rights towards the Data Controller, as expressed in art. 15 and ss. of the EU Regulation 679/2016.

In addition to these rights, the interested party has the right to lodge a complaint with the Supervisory Authority in the event of a law.
